Saint Charles Borromeo Seminary has signed and returned the Recipient's Funding Certification and Agreement to the Department of Education and has awarded 50% of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to our students.

Saint Charles Borromeo Seminary has received and awarded \$31,292.00 to students as of 45 days from receipt of funding.

The estimated number of students at our institution who participated in the Federal student financial aid programs during the Spring 2020 semester was 23 students. Twenty-three students received an Emergency Financial Aid Grant.

The Emergency Grant was awarded in two different amounts. Federal Pell Grant eligible students were awarded a \$1,787.50 Grant and Federal Direct Loan eligible students were awarded a \$1,150.00 Grant.

The Emergency Grant were awarded in two different amounts. Federal Pell Grant eligible students were awarded a \$2,668.00 Grant and Federal Direct Loan eligible students were awarded a \$2,050.00 Grant.

The Supplemental Emergency Financial Aid Grants were awarded in two different amounts. Federal Pell Grant eligible students were awarded \$3,563.00 and Federal Direct Loan eligible students were awarded a \$1,780.00.
